ORDERS BY THE GOVERNOR

NOTIFICATION

Dated Shillong, the 2nd February, 2019.

No.DCA.43/2018/41:- Whereas, the Governor of Meghalaya had vide Notification No.DCA.43/2018/28 dated 8th January, 2019 under Rule 129 of the Assam & Meghalaya Autonomous Districts (Constitution of District Council) Rules, 1951, as amended, published in the Official Gazette of Meghalaya Extraordinary dated 8th January, 2019, appointed the schedule of dates for publication of Draft Electoral Rolls, Filing Claims and Objections, Disposal of Claims and Objections and Publication of Final Electoral Rolls for every constituency of the Khasi Hills Autonomous District Council and Jaiñtia Hills Autonomous District Council on 30th January, 2019;

Now, therefore, in exercise of the powers conferred by sub-rule (2) of Rule 124 of the afore-mentioned Rules of 1951 the Governor of Meghalaya is pleased to call upon all the constituencies of the Khasi Hills Autonomous District Council and Jaiñtia Hills Autonomous District Council to elect persons to fill the vacancies and appoints with respect to the General Elections, 2019 of the said Councils:-

- (i)** the 8th February, 2019 (Friday) before 3:00 P.M. as the last date for filing of nominations {Rules 133(2) (a) & 133 (3)};
- (ii)** the 8th February, 2019 (Friday) after 3:00 P.M. as the date of scrutiny of nomination papers {Rule 133(2)(a) & 135(1)};
- (iii)** the 9th February, 2019 (Saturday) as the last date of Last date for withdrawal of nomination papers {Rule 133 (9)};
- (iv)** the 12th February, 2019(Tuesday) as the date of finalization and publication of valid nomination and allocation of symbol {Rule 135 (4)};
- (v)** the 27th February, 2019 (Wednesday) as the date on which a poll shall, if necessary, be taken {Rule 133(2)(b)};

and fixes 7:00 A.M as the hour at which the poll shall commence and 4:00 P.M. as the hour at which it shall close on the date for the poll specified above {Rule 140(1)}

- (vi)** the 2nd March, 2019 (Saturday) as the date of counting;
